

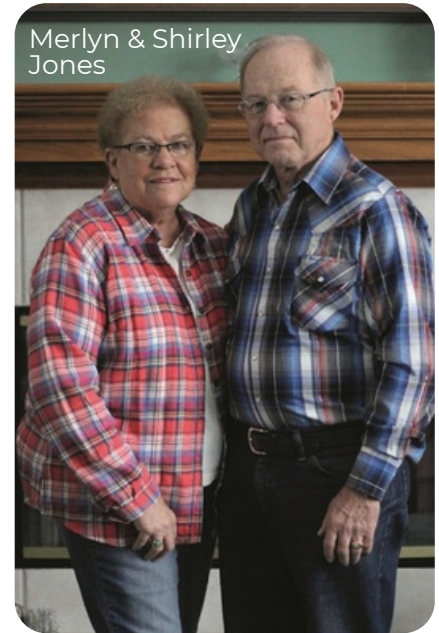

## Creating Opportunities for the Next Generation

Every scholarship at the Community Foundation of Dunn County begins with someone who believes in the potential of local students. In 2025, several generous families chose to honor loved ones, careers, and lifelong passions by creating new scholarships that will help students pursue education and career goals. These funds reflect the many ways people choose to give back; whether celebrating a lifetime in agriculture, honoring a beloved family member, or supporting the next generation of teachers, entrepreneurs, and skilled trades professionals.

### The Merlyn & Shirley Jones Scholarship Fund

One of the new scholarships established this year celebrates the life and legacy of Merlyn Jones, a 1958 graduate of Boyceville High School whose roots in agriculture and community ran deep. Merlyn grew up helping on his family's farm and was active in FFA and 4-H—experiences that sparked a lifelong interest in agriculture and eventually led to a career in agricultural research and leadership. After many years away, Merlyn and his wife Shirley returned to Boyceville and remained closely connected to the land and community that shaped his early years. This scholarship will provide a \$1,000 award each year to a Boyceville High School senior pursuing agriculture, political science, or business, with preference given to students involved in FFA, 4-H, or Science Olympiad.



## Additional Scholarships Established in 2025

### McKenna Marie Kay Johnson Memorial Scholarship

Created by Larry Johnson in memory of his granddaughter, this scholarship supports students pursuing hands-on careers in trucking and transportation fields such as diesel mechanics, logistics, and commercial driving.



### Beverly K. Meritt Legacy Scholarship for Educational Studies

Established in memory of educator Beverly Meritt, this scholarship supports Menomonie High School seniors pursuing degrees in elementary or special education, continuing her lifelong commitment to helping students grow and succeed.



### Linda Krueger Legacy Scholarship for Business/Entrepreneurial Studies

This scholarship honors Linda's career that blended teaching with business leadership. It supports Menomonie High School students pursuing degrees in business, finance, accounting, or related fields.



### Tim DeAtley Memorial Scholarship

Established by Tim's wife Lynda Stewart, this scholarship supports students pursuing automotive and diesel mechanics, honoring Tim's passion for hands-on work, craftsmanship, and community involvement.

# HELP MAKE A SPLASH IN COLFAX

## Community Effort Aims to Build Dunn County's First Splash Pad

A group of dedicated Colfax residents is working to bring Dunn County's first splash pad to life. The project would create a free, family-friendly water play area where children can cool off and families can gather during the summer months. The splash pad is being planned as a community project supported by local donors, businesses, and volunteers who want to add a new recreational feature to Colfax's park system. To help manage donations, supporters have established the Colfax Splash Pad Project Fund at the Community Foundation of Dunn County.



Community members and businesses are invited to help make this project possible through donations and sponsorships. Sponsorship opportunities are available for those who want to play a visible role in bringing this new community amenity to Dunn County.

The largest gift to date comes from Dakota's Gift, a donor advised fund at the Community Foundation that supports individuals with disabilities and illnesses. Their \$50,000 donation will help ensure the playground and restroom facilities are fully accessible and inclusive for families of all abilities.

As of March 11, about \$85,000 has been fundraised (including a recent \$10,000 sponsorship from WESTconsin Credit Union) and donated to the Colfax Playground and Splash Pad Project Fund at the Foundation. The project is tentatively slated for completion for September 2027.

Sponsorship options range from personalized paver stones to name placement on the playground are available. The project has a \$300,000 fundraising goal.

## CBJ Kids to Camp Scholarship Program

Honoring Cammie B. Johnson, this scholarship helps youth living with diabetes attend a diabetes summer camp of their choice.

**Award: \$250-\$850**

Funds are paid directly to the camp.

**Deadline: Apply at least 8 weeks before the camp of choice begins**



## The Barb Schmelzle Promise Award for Women

Supports non-traditional women students pursuing education while facing financial need and significant life challenges.

**Award: Up to \$1,000**

**Application period: May 1 – July 1**

## The Dr. James & Gail Haemmerle Scholarship

This scholarship provides full tuition support for a non-traditional student pursuing an associate degree, technical diploma, or certificate program. Applicants must demonstrate financial need and live in Menomonie or surrounding Dunn County communities.

**Application period: May 15 – July 1**



## The Bill Cowden Memorial Aviation Scholarship

Supports midwest pilots pursuing advanced aviation ratings or training.

**Award: Up to \$1,500**

**Application Period: March – May**



## Drums Along the Red Cedar Youth Music Camp Scholarship



Provides funding for Dunn County middle or high school students to attend a music camp of their choice (band, choir, jazz, percussion, voice, strings, etc).

**Award: Up to \$500**

**Deadline: May 15**
